### **Purpose of Position**

Ensure safety of school children and other pedestrians.

#### **Essential Duties and Responsibilities**

- Ability to direct traffic
- Ability to work in all types of weather
- Be available during school week / hours
- Must possess strong communication skills
- Must be able to read and understand street signs and directions

### Perform other duties as directed

#### Job Context

The Crossing Guard is a part-time, permanent position in the City of Laurel Police Department. The immediate supervisor for this position is the Deputy Chief. The person in this position is supervised on a daily basis and has no supervisory authority. The Crossing Guard works ten (10) regular hours per week, Monday through Friday, during the regular school year. The person in this position will assist children in crossing the street on their way to and from school. Crossing guards provide safe crossings of the roadways and model appropriate street skills and behavior for children.

### **Certification, Education and Experience**

Certification: A valid Mississippi driver's license or State Issued Identification Card is required for this position.

Education: A high school diploma or its equivalent is *preferred* for this position.

**Experience:** No experience is required for this position.

## **Physical Requirements:**

Must be able to lift and hold traffic sign for extended periods of time

Must be capable to extending the hands and arms in any direction; handling, seizing, holding, grasping, turning, or otherwise working with the hands/fingers

Must be able to turn head and body to observe traffic and children approaching

Must be able to sit and stand for long periods of time.

Must have sufficient vision to observe vehicles and pedestrians, read signs, and recognize potentially dangerous traffic situations and environmental hazards such as potholes, ice, sidewalk obstructions.
